

THE 2023 ENMARKET “ENJOY WINNING” DIGITAL GAME” OFFICIAL RULES

The 2023 Enmarket "Enjoy Winning" game promotion (the "Digital Game") is offered by Enmark Stations Inc. d/b/a/ Enmarket ("Game Sponsor") and is administered by WSP International Limited ("Administrators"). Game Sponsors and Administrators herein will be referred to as the Game Entities.

No Purchase Digital Tickets: You can obtain Digital Game Tickets without making a purchase (“No Purchase Tickets”) by sending a 3” x 5” card legibly printed with your name, your Enjoy Rewards card number and your email address, to "Enjoy Winning Digital Ticket Request, c/o 600 Main Street, #300, Tonawanda, NY 14151-0888". AFTER SEPTEMBER 5, 2023, NO DIGITAL TICKETS WILL BE ELIGIBLE TO BE OPENED TO REVEAL ANY OF THE DIGITAL GAME MESSAGES AS INDICATED HEREIN.**

3A) INSTANT WIN: When you open your Digital Ticket, select tickets will reveal a message stating, “You’ve Won!” followed by the description of an Instant Product Prize or a Fuel Discount (either \$0.01, \$0.02 or \$0.05 off per gallon), collectively Instant Prizes (“Instant Prizes”). Overall odds of winning an Instant Prize are 1 in 8. The approximate total retail value for all Instant Prizes is four hundred thirty-one thousand, four hundred ninety-one dollars and sixty cents (\$431,491.60).

3D) DIGITAL ONLINE SWEEPSTAKES PRIZES:

There are a total of one hundred and thirty-six (136) Digital Online Sweepstakes Prizes (“Sweepstakes Prizes”) available to be won, following the schedule outlined in Table 3 below. There are one hundred and twenty-six (126) Daily Prizes of a twenty-five-dollar (\$25.00) Enmarket Cash Card, nine (9) Prizes of Free Fuel for a Year each valued at two thousand dollars (\$2,000.00), and one (1) Grand Prize of twenty-five thousand dollars (\$25,000.00) cash. 4) NOTIFICATION AND REDEMPTION:

For Instant Win Prizes: All prize claims are subject to verification by Administrator and/or personnel authorized by the Game Sponsor at the Participating Location at which the prize claim is presented and surrendered for redemption. A minimum of three (3) attempts will be made to contact any potential winner. As a condition of awarding any Digital Online Sweepstakes prize, winner must have signed and returned, within seven (7) days of receipt, the Game Sponsor’s Compliance, Release, and Indemnity Form under which, among other matters, winner confirms his/her compliance and eligibility with these Official Rules, completes, provides proof of identity and releases and indemnifies Game Sponsor, Administrator and other certain parties. Game Sponsor may match aggregated statistical use information to parameters established by third parties, without releasing user information. This information will not contain any personally identifiable information. Game Sponsor may share aggregate information with trading partners, co-branded locations, participating sponsors and advertisers; however, this aggregated information will not contain personally identifiable information.
